#### **LEGAL REMEDY:**

The foreigner concerned may appeal with in 8 days following the date of refusal of entry. The appeal is decided by the Ministry of Interior of the Republic of Serbia, and shall be submitted via border police

station issuing refusal of entry, or via diplomatic or consular mission of the Republic of Serbia abroad, in serbian language, with payment of administrative fees in the amount of \_\_\_\_\_ dinars.

The appeal does not prevent enforcement of the refusal of entry, except for reasons prescribed in Article 83 of Law on foreigners.
