**2. Type of contracting authority: State authority.**

3. Type of public procurement procedure: open procedure of public procurement of goods with framework agreement. The public procurement procedure is conducted for the purpose of concluding a framework agreement on public procurement with at least 2 (two) bidders, that is, with all bidders that fulfill the mandatory and additional conditions for participation in the public procurement procedure pursuant to Articles 75. and 76. of the Law. The subject of the framework agreement is to determine the conditions for issuing orders for the goods in question.

If the contracting authority does not receive a pre-determined number of acceptable bids, contracting authority will make a decision in according to article 109. paragraph 1 of the Law on Public Procurement.

**Deadline for submission of bids is: November 28, 2019. until 10.00 hours.**

9. **Place, time and way of opening tenders:** Opening of tenders is public and will be held immediately after the expiration of the deadline for submission of bids, on November 28, 2019. at 12.00 hours, in the premises of the Client in Belgrade, Bulevar Zorana Đinđića 104, in the presence of members of the Commission for the subject public procurement.

*Conditions for participation of bidders' representatives in the offers opening procedure:*

*Opening procedure can be attended only by authorized bidders' representatives. Before start of the public procedure for opening of offers, bidders' representatives will be obliged to hand over to the purchaser written authorization (power of attorney) as a proof that they are authorized to attend public procedure for opening of offers.*

10. **Decision deadline:** deadline for decision on framework agreement award is 25 days from the day of opening of offers.
